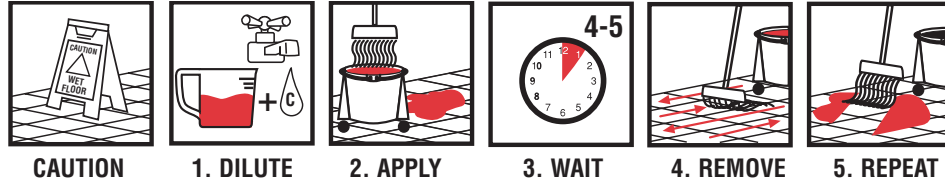

DIRECTIONS

## USE INFORMATION:

Use the Green Option™ Floor Care System of Green Option™ Floor Sealer/Finish, Green Option™ Floor Stripper and Franklin's Lightning Blend #9 Floor Cleaner for an environmentally responsible floor care program. Before stripping always dust mop the floor using a Fuller Brush dry mop and remove gum, labels and other attached soil deposits with a long handled scraper or putty knife.

## FLOOR STRIPPING



## FLOOR STRIPPING

- 1. DILUTE** at 16 ounces per gallon (1:8 ratio) of cold water for normal stripping.  
32 ounces per gallon (1:4 ratio) of cold water for heavy stripping.
- 2. APPLY** the diluted solution of **GREEN OPTION™ Floor Stripper** onto the floor with a mop.
- 3. WAIT:** Let stand for 4-5 minutes, then agitate with the same mop.  
For best results use a rotary machine and black pad. Do not let solution dry.
- 4. REMOVE** the solution from the floor using a mop or wet dry vacuum.  
For best results rinse the floor with clean water and a clean mop.
- 5. REPEAT** steps two to four if any finish remains on floor.

**NOTE:** THIS PRODUCT IS INTENDED FOR USE WITH DISPENSING EQUIPMENT.

**SPECIAL PRECAUTIONS:** Not for use on linoleum, tile in poor condition, wood or painted surfaces or for daily maintenance of resilient tile floors. Before use on asphalt tile or rubber, test a small hidden area for any color change.

## FIRST AID:

**In case of contact,** immediately flush eyes or skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. If easy to do, remove contact lenses. ## HANDLING AND STORAGE:

**SUGGESTED STORAGE TEMPERATURE:** Store inside at 40-90°F. **SPECIAL HANDLING AND STORAGE:** Handle in accordance with good industrial hygiene and safety practices. These practices include avoiding unnecessary exposure and removal of material from eyes, skin and clothing. Store in a cool, dry, ventilated area. **Protect from freezing.** Thoroughly rinse empty containers.
